By executing this adoption agreement, the conference hereby acknowledges, understands and agrees that:

- This adoption agreement shall not be effective unless and until it is accepted in writing by Wespath;
- The conference shall comply with Supplement One to CRSP, as amended from time to time, and the rules, regulations and procedures promulgated by Wespath, or its successors;
- If Supplement One to CRSP is amended in accordance with plan provisions, a new adoption agreement may be required by Wespath;
- The General Conference has the right to terminate Supplement One to CRSP at any time in accordance with plan provisions; and
- In the event of any discrepancies between this adoption agreement and the Supplement One to CRSP plan document, the Supplement One to CRSP plan document shall govern.

Section 6 - Adoption

The undersigned, a duly authorized representative of the conference, hereby declares the conference's desire to adopt or amend Supplement One to CRSP and hereby certifies that the conference's appropriate officers and/or governing board has:

1) authorized the conference's adoption or amendment of Supplement One to CRSP as of the Effective Date set forth in Section 1 of this adoption agreement and as set forth herein; and 2) directed the undersigned to execute this adoption agreement on behalf of the conference.
