Part 4 – Plan Sponsor Acknowledgements

By executing this adoption agreement, the conference hereby acknowledges, understands and agrees that:

- 4.1 Upon acceptance of this adoption agreement by Wespath, the conference will become a plan sponsor as defined in CRSP.
- 4.2 The plan sponsor will comply with CRSP, as amended periodically, and the rules, regulations and procedures promulgated by Wespath, or its successors.
- 4.3 If CRSP is amended in accordance with its amendment provisions, Wespath may (but need not) require the plan sponsor to execute a new adoption agreement.
- 4.4 In the event of any discrepancies between this adoption agreement and the CRSP plan document, the plan document will control.

- 4.5 The plan sponsor will enroll clergy in CRSP within 60 days of satisfying the applicable eligibility requirements.
- 4.6 The plan sponsor will maintain accurate records reflecting participant service and compensation and will provide data relevant to plan administration to Wespath in a timely manner.
- 4.7 The plan sponsor will notify Wespath of the termination of employment, retirement, disability, death or leave of absence of any participant as soon as possible but in no event later than 90 days following the event.
- 4.8 The plan sponsor will limit total contributions to CRSP and the United Methodist Personal Investment Plan (UMPIP) to the lesser of the annual dollar limit under Internal Revenue Code (Code) section 415 or 100% of Code section 415 compensation (generally taxable compensation plus before-tax salary deferrals, but not including housing allowance or parsonage.)
- 4.9 The plan sponsor will remit contributions to Wespath in a timely manner as required by CRSP. Late contributions may require payment of investment earnings and fees as specified in CRSP and applicable procedures.
- 4.10 The General Conference of The United Methodist Church has the right to amend or terminate this plan at any time.

Part 5 – Effective Date

Adoption agreements should be reviewed annually. The existing adoption agreement will continue to govern until the first of the year following acceptance of a new adoption agreement by Wespath.

The effective date of this amendment is January 1, 20_____.
