

**Rationale:** Clarify General Conference’s view of “affiliation with The United Methodist Church” for institutional investing, preferable to secular regulators drawing such lines; ensure emerging expressions of Methodism can rely on Wespath’s services, granting continuity/certainty and benefit of scale; memorialize fiduciary duty owed institutional investors distinct from that owed to plan participants.
