

Rationale: UMC investors that hold government issued securities should engage governmental bodies, to the extent reasonable and legal, and policymakers in supporting and improving sustainability and social responsibility, just as they are encouraged to engage similarly with companies whose securities they hold; and consider risk-justified exclusion only as a last resort.
